

Examples of Reportable and non-Reportable Activities referenced in Article 19

Need not be disclosed	Must be disclosed
Uncompensated external work that does not use appreciable University resources (FSU equipment, staff, students)	Uncompensated external work that uses appreciable University resources (FSU equipment, staff, students)
Uncompensated internal work, for example, as Faculty Advisor for an FSU RSO	
	Financial support from a foreign government or foreign private entity, excluding interest, dividends or pensions.
Compensated external work unrelated to your institutional expertise	Compensated external work related to your institutional expertise, for example, a non-FSU teaching appointment
Equity interests managed through retirement accounts or by a third party with discretion, such as mutual funds, ETFs, stock ownership of five percent or less of a company, pensions, and disability payments	Management role or financial interest (self, spouse, or dependent child) greater than five percent in a company that does business with FSU
	Financial interest (self, spouse, or dependent child) of greater than one percent \$5,000 five percent \$5,000 in a publicly traded entity related to your institutional expertise
	Ownership (any percentage, interest, or value) of a privately held business, including a consulting business, related to your institutional expertise
Royalties received from FSU	Royalties received from outside FSU that exceed \$5,000 in a calendar year
Intellectual Property that does not generate income	Intellectual property that generates income
	Requiring FSU course materials that you authored for which you expect to receive payment or royalties exceeding \$500 in a calendar year
Travel sponsored by FSU or a governmental agency or research center	
Payment of an honorarium that does not exceed \$5,000	Payment of an honorarium that exceeds \$5,000 or honoraria from a single entity that total more than \$10,000 in a calendar year






